In addition, the position includes communication with co-workers, contractors, and public patrons professionally and courteously. Work hours may consist of extended and working outside of regularly assigned hours to accommodate variable duties. This position is an hourly position and qualifies for overtime pay.

Duties

- Manage lawn, turf, and landscaping assignments, including but not limited to mowing, seeding, planting, and irrigation system management.
- Handle daily cleaning and trash removal, patron relations, construction management with vendors, and other responsibilities as assigned
- Manage chemical application for lawn areas and be willing to carry the Ohio
 Department of Agriculture Pesticide Applicator License on behalf of Capitol South
- Responsible for preventative maintenance, minor repairs and weekly inspections of the carousel, and coordination of Ohio Department of Agriculture carousel annual permit
- Perform minor electrical, plumbing, irrigation and HVAC repairs, and manage contractors as needed
- Serve as the primary snow-removal team member
- Assist with holiday light installation/removal, and other event tasks as needed
- Plan, install, and maintain public garden spaces and coordinate with contractors as necessary
- Under the direction of Operations Manager, supervise and train seasonal operations team members
- Responsible for park vehicle maintenance and record management
- Operation of various vehicles is required

Qualifications

- A minimum of two years of experience working in commercial landscaping, specifically with turf fertilizers, herbicides, and pesticides
- At least two years of post-secondary education or equivalent training is preferred
